Please note that Adhyatma Commercial Private Limited (hereinafter referred to as "ACPL"), is acting in concert with the Promoter (Mr. Hemant Kanoria) of Srei Infrastructure Finance Limited (the Target Company) and ACPL is part of the Promoter/ Promoters' Group of the Target Company.

ACPL, the acquirer & the person acting in concert with the promoter, has acquired 1,00,000 Equity Shares and 50,000 Equity Shares of Rs. 10/- each being 0.0199% and 0.0099% of the total paid up Capital of the Company on 21st August, 2012 and 22nd August, 2012 respectively.
